# **ABOUT US**

FORM Dance Projects (previously known as Western Sydney Dance Action) is a unique, innovative cultural service provider that aims to foster and develop contemporary dance culture in Western Sydney. Form Dance Projects delivers a vibrant, engaging dance based artistic program creating professional development opportunities for emerging to established choreographers and dancers. FORM provides access to dance education, appreciation and participation opportunities for the Western Sydney community.

Since its inception in 2001, as Western Sydney Dance Action, the organisation has established strong networks with local and state government, education and community based sectors, and has a Board comprised of representatives from government, business and the arts.

FORM Dance Projects has matured from a small dance service provider into a professional arts organisation with a growing reputation for presenting a high calibre artistic program of contemporary dance works. FORM has delivered projects in partnership with high profile arts organisations such as Sydney Festival and the Australian Chamber Orchestra.

FORM presents a curated multi-stranded dance program across the four key areas of presentation, education, professional development and community outreach. FORM creates, shape and forms a diverse program of dance projects in collaboration with choreographers, dancers and artists.

These projects are presented throughout the year in a signature season, Dance Bites, or special events, creative development projects, education workshops, masterclasses and programs such as Fast+Fresh Dance. A key driver for FORM is facilitating professional development for Western Sydney choreographers and dancers. The emergence of new dancers via pathways provided by education, mentoring and auspicing programs is testimony to a growing degree of success.

FORM maintains strong community partnerships through links with key service providers such as STARTTS, the NSW Service for the Treatment and Rehabilitation of Torture and Trauma Survivors, and Community First Step, a Fairfield based service provider. FORM auspices CPAN, the Cultural Performing Arts Network, representing over 300 community cultural performers in Western Sydney.

# **MESSAGE FROM THE CHAIR**

In 2012 Form Dance Projects consolidated the exciting vision embraced by our organisation through the successful renewal process commenced the year before.

# **PROGRAM OVERVIEW 2012**

FORM Dance Projects came into its element in 2012, developing programming initiatives and partnerships and consolidating the education program. It was an exciting year of activity engaging with independent dancemakers and creating diverse opportunities for artists in the dance sector. Many artists have responded with enthusiasm to what FORM represents for them, in a landscape where opportunity for independent performers to present their works is becoming progressively narrow.

The Dance Bites 2012 program was launched in March with a presentation of independent choreographer Anton's first feature length work, SuperModern Dance of Distraction. This fast-paced clever and captivating new work was extremely well received by audiences and critics. Choreographer, Liz Lea came back to the Western Sydney fold with a presentation of 120 Birds, which delighted audiences both young and old. An homage to the touring company and Anna Pavlova, with its reminiscent routines of social dance and retinue of costumes and vintage film footage featuring a stellar performance by Miranda Wheen.

In August, De Quincey Co presented FRAMED, a meditative exploration of the Natyasastra, which resonated and lingered with many who experienced the installation style performance by Tess de Quincey and Victoria Hunt. The final Dance Bites 2012 was presented in October and featured Prime: Orderly, choreographed by Dance Fellow, Australia Council for the Arts, Dean Walsh. Prime: Orderly was the culmination of two years of research into the marine environment and the evolution of Dean Walsh's new choreographic scoring system. The 2012 Dance Bites program demonstrated the breadth and diversity of contemporary dance in NSW.

New projects initiated by FORM in 2012 included the Blog Residency, an annual commission for an invited choreographer to share their views on everything dance. This was launched in 2012 with the award winning and highly regarded independent choreographer and performer, Martin del Amo. FORM developed a successful partnership with the Australian Film Television and Radio School to present the AFTRS Dance Film Masterclass which sold out in July 2012, facilitated by Richard James Allen from Physical TV Dance. Another strong partnership was forged between FORM Dance Projects, Legs On The Wall and VOX, Sydney Philharmonia Choirs' youth choir, to creatively develop an exciting new cross-disciplinary project, Puncture, over the next two years.

FORM's education strand is growing stronger each year and provides Secondary School performing arts students, particularly in Western Sydney, with unique access to artists and participation in specialised skills workshops. The immersive Choreographic Workshop was presented by FORM and facilitated by Kay Armstrong's youMove Company. The popular Fast+Fresh Dance youth competition for emerging choreographers and dancers continues to capture the imagination of the next generation of young dance makers and provide unique performance and professional development opportunities.

FORM greatly appreciates the Triennial funding from Arts NSW and the enduring partnership with Riverside and support of Robert Love, Riverside Director. FORM is grateful to Parramatta City Council for its project funding in 2012. This enabled FORM to initiate Puncture and engage emerging Western Sydney mentorees and to auspice CPAN, the Cultural Performing Arts Network.

FORM thrives on the energy and creative contribution of many people. Thank you to all the artists who participate and contribute to the artistic program and the many partners and sponsors who enable FORM to deliver the artistic and education programs.

A special thanks to FORM's Board for their commitment and advocacy in promoting the work of the organisation and FORM's staff who keep the wheels turning and create a positive and nurturing environment for dancemakers in NSW. FORM reached its potential in 2012 becoming a lighthouse organisation presenting and contributing to the sustainability of contemporary dance culture in Australia.

### **Director – Annette McLernon**

Annette McLernon comes to FORM Dance Projects as an experienced Arts Manager, having worked for many leading arts organisations and festivals in Australia. Annette has worked as Film Program Manager for Perth International Arts Festival (WA) and Program Manager for Bundanon Trust (NSW). She enjoyed assisting with the marketing of Spring Dance 2012 with Sydney Opera House and was a Programming Assistant for the 2012 Sydney Christmas program with the City of Sydney Events team.

She has performed and trained as a dancer from a young age and has taken on the role of choreographer for multiple amateur Musical Theatre productions over the past four years, co-ordinated auditions for the Sydney Fringe Festival, produced her own contemporary work Day-Tripper at The Red Rattler, Marrickville in 2011 and choreographed for Emu Heights Productions 2012 adaptation of Hamlet at The Joan, Penrith.

### **Education Coordinator – Carl Sciberras**

Carl Sciberras is an emerging dance artist from Western Sydney. Carl has a Bachelor of Arts (Dance) and a Bachelor of Arts in Communications (Writing and Cultural Studies) from the Western Australian Academy of Performing Arts and the University of Technology Sydney respectively. 

### Curtain Call, Crikey.Com, Lloyd Bradford Syke, April 4 2012

Parramatta, to some, is still 'the sticks', relatively and culturally speaking, but this proves to be an inaccurate and outmoded notion. Of course, if you relied on the narrowcast predilections of the popular press, you'd never really know Parramatta even exists. Which affords the possibility, for the slightly more intrepid journalist, of locking onto something artistically worthwhile and feeling smug about it.

That's how I feel, in a small way, about Form Dance Projects and Riverside's co-production of SuperModern Dance of Distraction.

### Real Time Magazine, June/July 2012 Being Human at Critical Mass, Jodie McNeilly, Anton, Super-Modern Dance of Distraction.

In a more literal demonstration, clear Perspex held between faces becomes a touch screen: connections are unequivocally established between fingers, glass and manipulated expression. (See cover image). The audience laughs rapturously (perhaps those with iPhone or iPad much harder.) The Perspex intercepts the kissing lips of two lovers in a moment of "distal loving". Pressed together they exaggerate the mediated space-time distance that Skype technology attempts to bridge. When four, the dancers constitute a visual spectacle. In synchronous movements they generate

images of a mechanic ballet and tessellations of leg and faces spinning hypnotically in a Busby Berkeley water parade.

### Sydney Morning Herald, Jill Sykes, Subtle Exploration of Emotions Inspired by Ancient Style, August 10, 2012

The slowness of the movement, which makes it almost imperceptible, comes from the Japanese butch core of their Body Weather movement style. If you have seen pure butch, you will know how extraordinary it can be - and it is here.

Framed is an esoteric piece worth catching, a collector's item.

### Sydney Morning Herald, Jill Sykes, Wonders of Water World Evoked in Entertaining, Educational Work, October 25, 2012.

Dean Walsh had a two year fellowship to research "marine sub-scapes and human-animal movement" for his work Prime: Orderly, and it shows. The thoughtful details he has brought together, including a short talk and questions and answer session with a marine biologist, diving or marine professional at each performance, gives the pence an unusual dimension... This is about alerting people to the wonders of the world underwater, the need to care for it and co-exist peaceably with its inhabitants.

FORM Dance Projects and Riverside Theatres, Parramatta are the courageous, collaborating, visionary forces that brought the short season of Tess de Quincey's Framed, as part of Dance Bites 2012, to Sydney's west. Let's hope it transcends those geographical boundaries, as it deserves.

# **AFTRS DANCE FILM MASTERCLASS**

28 – 29 July 2012

In 2012 FORM Dance Projects partnered the Australian Film Television and Radio School to present a new masterclass program led by dance filmmaker and choreographer Richard James Allen, from The Physical TV Company. FORM Dance Projects facilitated an audition to select four technically sophisticated, highly imaginative, flexibly responsive dancers to participate in the masterclass. The successful performers were; Kathryn Puie, Natalie Ayton, Rosslyn Wythes, & Jay Bailey.

### MASTERCLASS

This masterclass was for choreographers, dancers and filmmakers who are passionate about the dance film genre. The program explored the aesthetics of dance for the screen while also providing a practical collaborative experience for industry professionals.

Participants explored the evolution of dance film from the 20th century through to contemporary screen dance practice using the works of internationally recognised leaders. This historical overview was used within the context of the three main sub genres of the art form.

Participants were then instructed to 'play' in the studio during shooting exercises with cameras, dancers and movement, exploring concepts of time, energy, space and gesture in staging and framing, to see what kind of impact they could generate.

The masterclass focused on editing as a form of choreography and the affective impact of sound in dance film, exploring montage ideas – including collision and flow, timing, pacing and trajectory phrasing.

It was targeted towards choreographers, dancers and filmmakers at various stages in their careers from emerging (post graduates) to mid-career and established professionals. FORM Dance Projects

provided emerging artists with the opportunity to apply for a scholarship to participate in this master class. Anya McKee was the succesful recipient.

# **BLOG RESIDENCY**

MARTIN DEL AMO

### BIOGRAPHY

Martin del Amo, originally from Germany, is a Sydney-based dancer and choreographer. He is best known for his program length solos, fusing idiosyncratic movement and intimate storytelling. In recent years, Martin has extended his practice to choreographing group works and solos for others including Anatomy of an Afternoon (2012), Mountains Never Meet (2011) and various solos for his ongoing multi-part choreographic project, Slow Dances For Fast Times (2013).



#### 1. SUMMARY OF ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act NSW, 2009 and the Funding Bodies. The Committee Members have determined that the Association is not a reporting entity as defined in Statement of Accounting Concepts 1 "Definition of the Reporting Entity,"

These statements are prepared on an accrual basis from the records of the Association. They are based on historical cost and do not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

#### (a) Revenue and Other Income

Grant and donations income is recognised when the entity obtains control over the funds which is generally at the time of receipt. Interest revenue is recognised as revenue when received. All revenue is stated net of the amount of Goods and Services Tax (GST).

#### (b) Cash & Cash Equivalents

Cash and cash equivalents consist of deposits held at call with banks.

#### (c) Goods and Services Tax (GST)

The Association is registered for GST. Revenues, expenses and assets are exclusive of the amount of GST.

#### (d) Income Tax

No provision for income tax has been raised as the entity is exempt from income tax under Div 50 of the Income Tax Assessment Act (1997).

#### (e) Employee Benefits

Provision is made for the liability for employee benefits arising from services rendered by employees to balance date. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

#### (f) Plant and Equipment

All plant and equipment acquired have been expensed in the year of purchase in order to comply with the guidelines of the various Funding Bodies and the conditions of the grants.

To comply with Accounting Standard AASB 1021 "Depreciation of Non-Current Assets", plant and equipment expensed during the period must be added back to the surplus/(deficit) and the depreciation charges are then deducted accordingly.

Plant and equipment are depreciated over their expected useful lives.

At the date of this report the Committee has no reason to believe these bodies will not continue to support the operations of the Association.
